IMPORTANT REMINDER: APPRENTICE EVALUATIONS

Please complete evaluations on a desktop computer, not a mobile device, so all fields and ratings are captured accurately. And **don't skip the comments section**, your feedback is essential to this evaluation process.

The JMAP Training Committee relies on your evaluations to understand each apprentice's performance and readiness for advancement to the next class. The committee reviews them quarterly and follows up with supervisors when more information is needed. You'll receive calendar reminders when the evaluation system opens each month. If you're not receiving them, please let us know right away so we can correct it.

- 4th quarter: November 13, 2026

FIELD VISITS

During the course of the apprenticeship, each apprentice will receive at least one on-site visit at their utility from a member of the Joint Apprentice Training Committee (JATC).

JMAP TUITION REMINDER

Effective January 1, 2026, annual tuition for JMAP will increase to \$6,500 per apprentice. This amount includes the cost of printed training materials and textbooks.

PATHWAY TO A DEGREE: JMAP PARTNERS WITH NORTHWESTERN MICHIGAN COLLEGE

Northwestern Michigan College in Traverse City partnered with JMAP to award graduates beyond their journeyman certificate.

Both past and present JMAP graduates can be awarded nearly half of the credits needed to receive an associate's degree upon completion of the four-year journeyman utility line worker program through JMAP.

Three associate's degree options are available: General Studies, Construction Management, and Construction Technology with an emphasis in Electrical. To date, 171 graduates would be eligible for this opportunity.
